





Dear Mr. Engler,

The Palo Alto Police Department sent my attorney some new edited versions of the MAV videos created on October 12 and 13, 1008 seven months after the first versions were created.

I mailed you copies of these versions on Thursday, I expect you to receive them on Tuesday or Wednesday at the latest.

You will find that these new videos verify that editing has taken place and that the depicted images corroborate my allegation that Officer Burger first fired his Taser gun at my face without warning while I was in a completely defenseless position of holding my hands in the air above my head.

Watermark, no watermark, if a jury is ever given the opportunity to view these images, they will know what you have known, they will know the truth, that the police covered up an unlawful assault and battery of me by editing video evidence.

I hope you understand that all I am trying to do is to reveal the truth and protect my freedom and safety. The more information I provide to more people the safer I am.

On Tuesday December 8, 2009 at approximately 7:00pm at least possibly two undercover Palo Alto Police officers were conducting surveillance on me while I was at the University Ave Starbucks.

On Thursday December 17, 2009 at approximately 9:30 pm I was again at the University Ave. Starbucks. I was sitting outside in the patio area alone when two Palo Alto Police Officers arrived and sat down at a table next to me. In about three minutes six more uniformed Palo Alto Police Officers arrived took the remaining three tables and chairs literally boxing me in the patio area preventing me access to the exit without having to come in contact with the officers. The officers remained there for approximately 30 minutes.

On Monday December 21, 2009 there was a Palo Alto Police Patrol Car staked out next to my vehicle at approximately 8:50pm to 9:30pm.

I honestly believe that the officers who have committed the crimes against me will not allow me to bring my civil case to trial. One way or another, either directly or indirectly through others, they will do whatever they need to do to avoid being prosecuted. If you think that too far fetched, Chicago police officer Jerry Finnigan was plotting kill up to four fellow officers who were going to testify against him until another officer Keith Herrera informed the FBI of Finnigan's intentions.

Comment Or Question Message: I have made several official complaints to Attorney General Edmund G. I have been in communication with Senior Assistant Attorney General Gerald A. Engler for over eight months requesting that the Attorney General's office conduct an investigation and prosecute the culpable officers and Santa Clara County District Attorney Staff of the following crimes: 118(a); 118.1; 132; 134; 141(b) and 182 (1-5).

I have provided Mr. Engler with dozens of pieces of evidence verifying my allegations.

I have demonstrated that Santa Clara County District Attorney Dolores Carr refuses to hold the officers accountable because she refuses to investigate the evidence, such as analyzing the watermark on the MAV videos. I have proven that the crime lab has prepared a fraudulent analysis of the Taser-CAM videos.

I have made numerous requests to Mr. Engler that the Attorney General's office: analyze the watermark on the two MAV videos; obtain the original MAV videos; obtain the original Taser-CAM videos on MPEG4 files; download the data ports from the Taser guns;

traudulent analysis of the Taser-CAIN videos.
